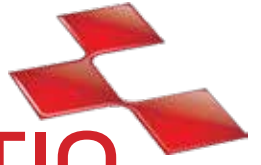

Koprivnica Križevci County is located in the continental NUTS region of Croatia in the northwestern part of the country and bordering with the Republic of Hungary. Considering economic development, the aim of raising the level of economic competitiveness of the County,

in long term, is focused on the process of technology transfer with the possibility for the new employment of qualified persons.

More than 150 hectares of communally equipped land in the entrepreneurial zones, in which the renowned domestic and foreign companies operate today, are prepared for the foreign direct investment in the County.

KOPRIVNICA KRIŽEVCI COUNTY

The comparative advantages of the region are contained in the transport links between the Rijeka - Zagreb - Koprivnica - Budapest port (Pan European Corridor VB), the proximity of state speedways, highways and border crossings and the future entry of the Republic of Croatia into the Schengen regime of passenger and freight traffic.

The entrepreneurial climate is strengthened by the possibility of using EU funds, state and local level benefits, especially for tax and utility costs, and the procedures for obtaining a building permit for construction are within the competence of the County and do not exceed 15 days.

In addition to the County administration, a system of support institutions has been established to support foreign investors, and a qualified response to each

inquiry is submitted within 3 days.

We are a Certified County based on the established standard of communication with foreign investors and our intention is to continue our friendly relations with future investors (CIFR certificate).

The Region of South East England is one of the most significant issuing areas for investors from other regions, so at the Going Global live investment fair in London we find the opportunity to present potentially profitable areas for future investors in the County's greenfield investments.

These are primarily the sectors of food, metal processing and pharmaceutical industry, where high added value is achieved and the growth potential stems from the increase of the purchasing power of the domestic market and the proximity of the European customer market, as confirmed by the renowned export companies based in the county, with constant growth of business profit.

The future construction of the 20MW geothermal power plant opens up the opportunity for investment in activities that use hot water distributed by cogeneration, the healthy environment and the beauty of the landscape allow investment in health tourism (spas and SPA centers).

The safety of living in the region is high, and the quality of public services to residents of health, pre-school and school care provided by the County is at a European level of accessibility and quality.

The rich cultural and natural heritage of the region is the base for tourist offer that consists of numerous galleries, museums, protected natural landscapes along the Drava River, wine and cyclo tourist roads, and is also presented at the events, some of which are winners of the European Prestigious Awards (Eden).

The safety of all citizens and their property in the County is taken care of by 311 police officers. They are dedicated to the care and maintenance of a favorable state of law and order, the safety of road transport, the suppression of all forms of crime and the protection of the state border.

SECURITY STATEMENT

Each year brings new challenges and a favorable state of security has been created so far, in the future the imperative to maintain this trend is imposed, as well as the pursuit of even greater security of personal integrity and property.

There were no terrorist activities in the area of 115.000 inhabitants in the last ten years. The killings mostly occur as a result of family disputes and the perpetrators are prosecuted.

In the economy, we most often encounter Fraud in Business, Abuse of Office and Authority, Forgery of Official Documents and Abuse of Trust in Business. Over the last ten years, there have been several criminal investigations in economic entities in the county, in which claims were recorded in millions. A series of computer frauds were also resolved, where software was used to remove funds from corporate accounts.

Often, criminal investigations by our police officers are spread and conducted in cooperation with police officers from other police departments, most notably drug offenses, where our officers report very good results in the detection and seizure of narcotics.

Lately, a lot of attention has been focused on detecting offenses related to illicit trade of tobacco and tobacco

products.

Corruption offenses have been on a rise with the increase around 2,5% of the total number of recorded crimes in the last ten years.

The number of committed offenses has halved from ten years prior. Police efforts are also focused on maintaining order at public gatherings, especially at sporting events, and reducing damage occurring after these events.

An average of 10 people are killed annually on the roads of the County, and there is a need for stronger and more intensive work to raise awareness among all road users about the fragility and importance of human life.

We are witnessing a large number of refugees passing through our country every day, so the security of the state border is becoming one of the priorities of police action, since the Ministry of the Interior itself wants to ensure standards for implementation and smooth entry into the Schengen area. Fortunately, the waves of refugees that followed in 2015 are has diminished.

It is also the task of the police to provide administrative services effectively for citizens, related to citizens' status such as driver and licence registers, weapons, citizenship, residence and work of aliens, and in this segment, too, through simplifying and speeding up procedures, to make it easier for citizens the exercise their rights.

The high level of security of our County is not only the responsibility of the police. Security is the result of the efforts of all institutions with different competencies and different jobs that are closely interconnected, so as before we will continue to implement many joint projects, both with institutions and citizens' associations, in order to continue to maintain a favorable state of security.

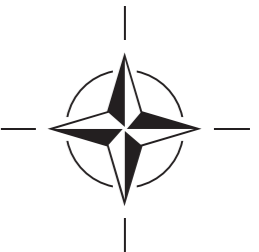

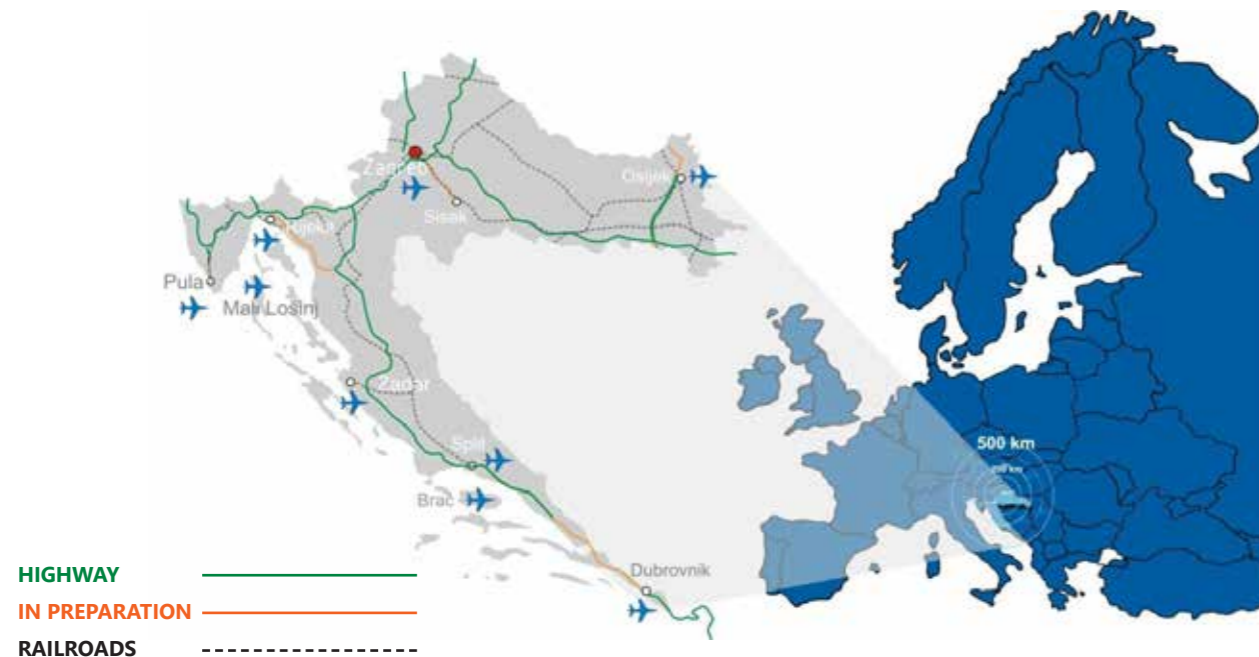




REPUBLIC OF CROATIA

From the northeast side it has a border with the Republic of Hungary. In the area of the Republic of Croatia the Koprivnica Križevci county borders with six counties: county of Međimurje, county of Varaždin, county of Zagreb, county of Bjelovar and Bilogora and County of Vi-

rovitica and Podravina. With an area of 1.748 km² Koprivnica Križevci County is one of the smallest counties in the state (17/21), ranked 16th with 115.582 habitants.

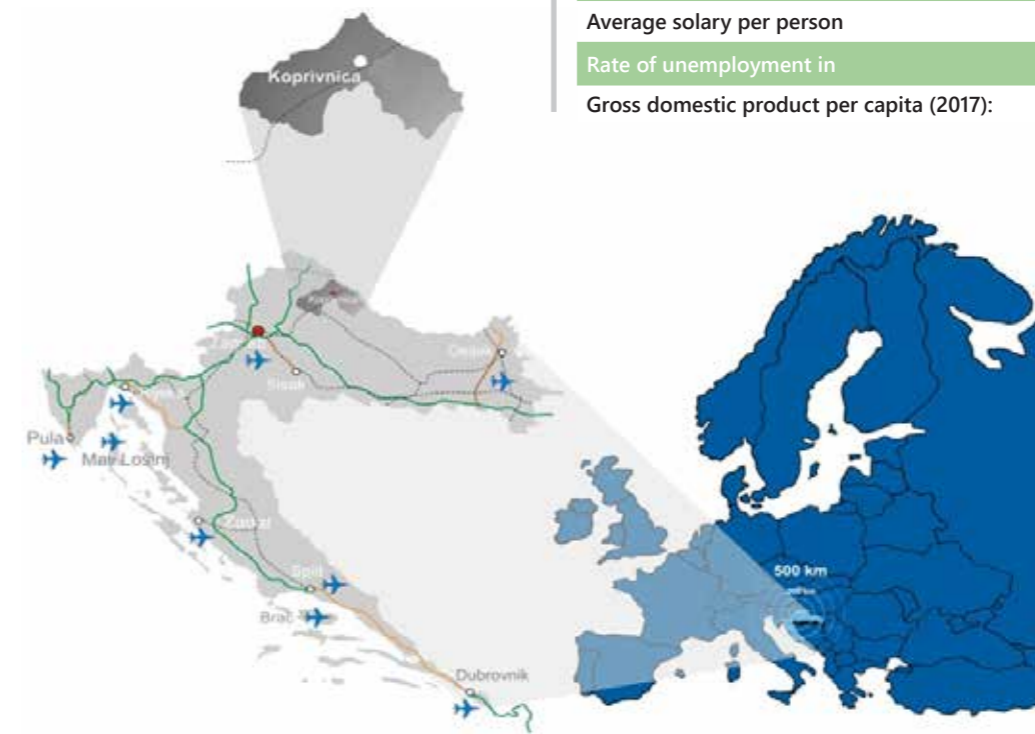

Reconstruction of railway section, which length is 14,3 km, started in August of 2014 with the cost of the project of 15,7 million Eur.

With numerous works on railway, also six railway and road crosses have been modernized.

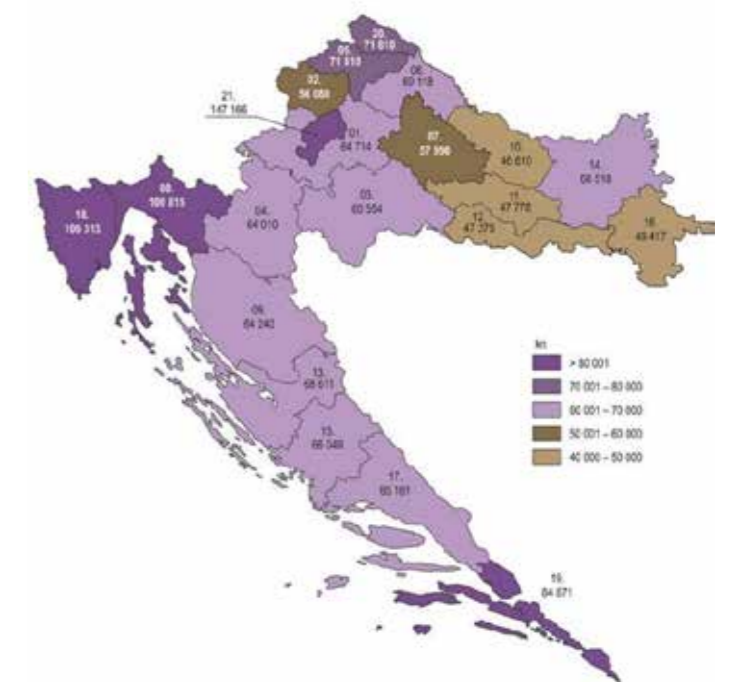

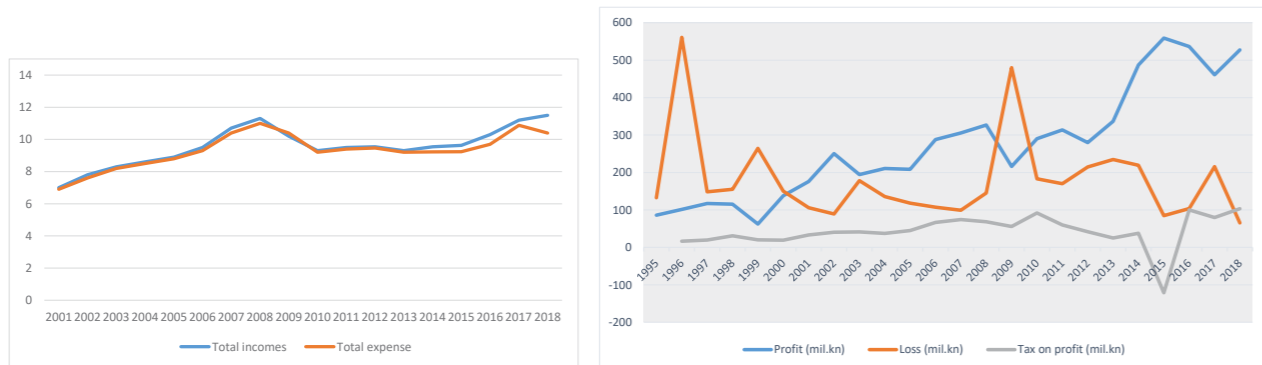

Graph 2. The trend of profit, loss and corporate income tax (mil. kunas)

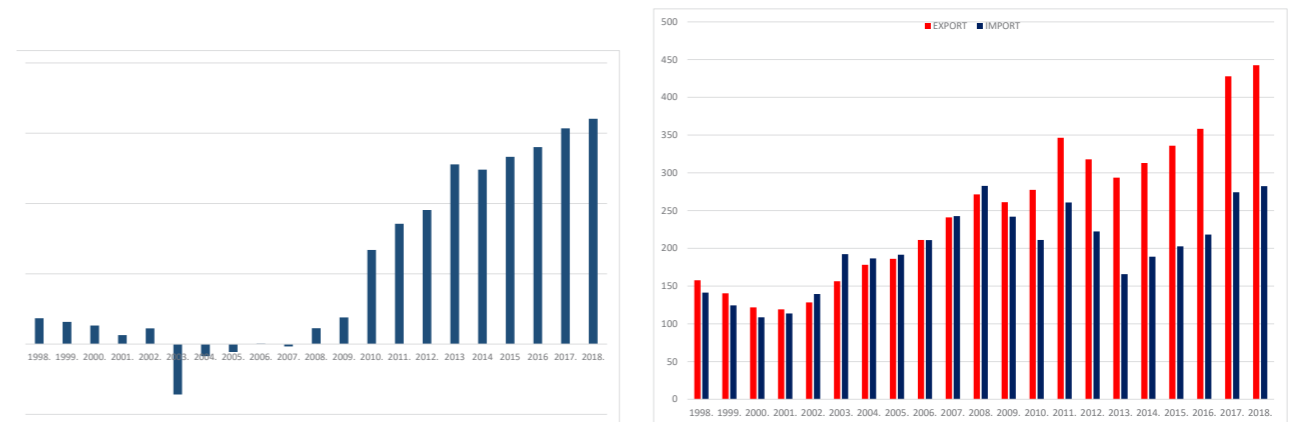

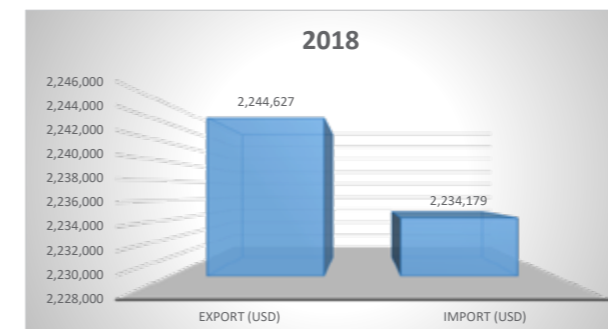

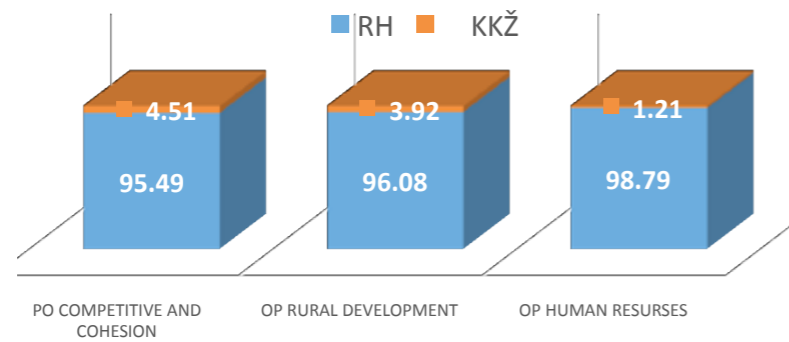

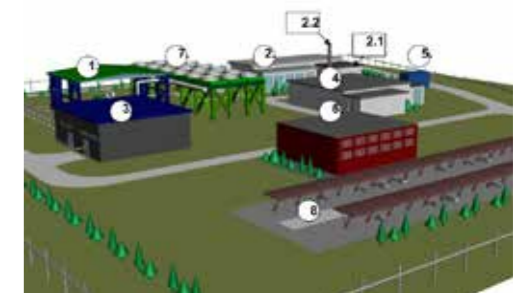
